

During her latest tenure as Speaker of the United States House of Representatives, Nancy Pelosi has continually demonstrated her callous disregard for the wellbeing for the American people.

By way of example, Speaker Pelosi has taken no action against Representatives who have engaged in falsification and/or fabrication of evidence. Take Representative Eric Swalwell, who on February 10, 2021, during the second Senate impeachment trial of President Donald J. Trump, introduced a tweet ostensibly obtained from the Twitter Account of Jennifer Lynn Lawrence, which stated, "It has been an honor to stand up and fight for you in our nation. We will be standing strong on January 6 in DC with you. We are bringing the Calvary, Mr. President." Ms. Lawrence subsequently admitted that she did post the tweet, with the word "Calvary" being a reference to a prayer vigil organized by churchgoers supporting Trump and not a call for military-like violence at the Capitol riot as portrayed by Rep. Swalwell. However, despite the fact that Representative Swalwell presented the United States Senate with a verified representation of Ms. Lawrence's tweet, Ms. Lawrence has indicated that she does not utilize a verified Twitter account. Such accounts are identified by a blue check mark and, according to Twitter, "let[] people know that an account of public interest is authentic. To receive the blue badge, your account must be authentic, notable, and active." <https://help.twitter.com/en/managing-your-account/about-twitter-verified-accounts>. Given that Representative Swalwell presented the Senate with a purportedly verified Twitter posting obtained from Ms. Lawrence's account when Ms. Lawrence does not have a verified Twitter account, it is apparent that Representative Swalwell introduced evidence during the impeachment hearing that was falsified and/or fabricated. Despite the fact that Representative Swalwell blatantly engaged in the falsification and/or fabrication of evidence, Speaker Pelosi has taken no disciplinary action against him. To the contrary, Speaker Pelosi has reappointed Representative to the House Intelligence Committee, despite his intimate sexual relationship with Chinese spy Fang Fang, who seduced US politicians as part of her work.

In another example, Speaker Pelosi has taken no disciplinary action against Representative Adam Schiff, who on December 13, 2021, presented text messages to the January 6 committee that appear to have been doctored and/or altered, thereby creating the impression in a visual presentation that he was quoting original text messages rather than fabrications. It should be noted that Representative Schiff has repeatedly faked evidence in investigations. In 2019, at the opening hearing of the House Intelligence Committee investigation into President Donald J. Trump, he faked a conversation between President Trump and Ukrainian President Volodymyr Zelenskyy. When caught, Representative Schiff tried to claim that he was merely acting out a "parody," rather than creating a false public impression. Later, in arguments before the Senate in President Trump's impeachment trial, Representative Schiff faked a Trump quote to President Zelenskyy, again. However, Speaker Pelosi seems as unfazed by Representative Schiff's fraudulent transgressions as she is by Representative's Swalwell's criminal actions and scandalous affair with the Chinese spy Fang Fang.

Speaker Pelosi has a well-documented history of standing by while other Representatives run amuck and assert tyrannical oppression on the American people without a single regard for the American people. For example, Speaker Pelosi remained silent as Representatives Maxine Waters and Ilhan Omar incited violence and sewed seeds of division among the American people. She has lost any semblance of control

she may have ever had over her legislative house, and she needs to be held accountable for her multiple and inexcusable derelictions of duty.

When she assumed the Role of Speaker of the House of Representatives, Nancy Pelosi took an oath of office pursuant to Title 5, Section 3331 of the United States Code. In so doing, Speaker Pelosi agreed to “support and defend the Constitution of the United States against all enemies, foreign and domestic;...[to] bear true faith and allegiance to the same;...[to] take this obligation freely, without any mental reservation or purpose of evasion,...[and to] well and faithfully discharge the duties of the office...” Speaker Pelosi has repeatedly violated this oath of office, and due to her numerous failures and criminal transgressions, I respectfully request that she be investigated and prosecuted to the fullest extent of the law.
